Liabilities:

Lambton Scientific's sole responsibility is to perform its services in accordance with commonly accepted professional standards using accepted testing methodologies and procedures, unless alternate standards or methods are prescribed by the "client". Although every care and due diligence is taken in the performance of our services, Lambton Scientific and its staff has no liability whatsoever for indirect, consequential, exemplary, incidental, special or punitive damages, including lost profits, resulting directly or indirectly from any errors or omissions. The extent of Lambton Scientifics' liability is limited to a refund of the analytical costs.

Confidentiality:

All results and information obtained by Lambton Scientific will be held in strict confidence unless (i) the client directs otherwise in writing, (ii) any disclosure or subsequently becomes generally available to the public without breach of any confidentiality agreement by Lambton Scientific, or (iii) disclosure is compelled by law, in which event Lambton Scientific will use reasonable efforts to give client prior notice.

Fees:

- Prices are based on list prices. Prices may be subject to change without prior notice. Pricing is available in Canadian or US dollars. Canadian clients are subject to GST (and PST if applicable).
- A minimum charge of \$75.00 (CDN) per order to be applied to all analytical work.
 For US clients, a minimum charge of \$50.00 (US) per order to be applied to all analytical work.
- Surcharge Rates for Priority / RUSH samples (RUSH service MUST be arranged prior to or at time of sample submission):
 - Normal analytical turnaround time is 4 to 7 business days, depending on the analyses required.
 - If priority or RUSH service is required, a 50% to 150% surcharge could apply, based on requested turnaround as follows:
 - 2 to 3 day turnaround subject to 50% surcharge.
 - 24 hour turnaround (by end of next business day) subject to 100% surcharge.
 - Same day turnaround (if possible) subject to 150% surcharge.
 - For RUSH service "day 1" is considered to be only if samples are logged in at Lambton Scientific prior to 11:00AM, otherwise day 1 is considered the next business day.

- Charge-Out Rates for Other Services:
 - \$ 100.00/hour/person Project consultation
 - \$ 80.00/hour/person On-site or field collection services performed during regular business days and hours, 8AM -5 PM (includes field vehicle and all sample collection supplies)
 - \$ 125.00/hour/person On-site or field collection services performed during offhours (nights, weekends, statutory holidays, etc)
 - \$ 125.00/hour/person Off-hours. general laboratory analytical services. For off-hours service, a pager/mobile phone system may be made available to clients with established service contacts. Work Authorization:

Authorization to proceed with the job/analytics is considered one or more of the following:

- Submission of a customer Chain of Custody form with the analytics specified
- Customer signature on Lambton Scientifics' Sample Submission Form with the analytics specified
- A received hard copy of the Purchase Order with the analytics specified

Miscommunication may result in turnaround time delays in processing sample(s). Sample(s) will be held in a state of quarantine until work authorization is clearly communicated.

Sampling Supplies:

Specialized sample containers, bottle labels, preservatives and Chain of Custody documentation can be supplied at no additional charge, provided that the analytical work is performed by Lambton Scientific. All designated coolers and ice packs are the property of Lambton Scientific.

Sample Shipment:

Samples shipped to Lambton Scientific must be properly labeled, packaged and documented as per applicable transportation legislation (including WHMIS). Samples which are suspected to be hazardous must be clearly marked as such prior to submission to the laboratory. Samples must be accompanied by clear instructions specifying: sample identification, sample details, Purchase Order Number, analytical requirements, distribution of report and invoicing information and any other applicable notes. Sample Storage / Disposal:
